3. No allowance will be made for Furniture Not Used.
4. A joint Inspection of all delivered items will be conducted by **Renter's Agent** and representative from **Coolthings**.
5. A Security Deposit or Credit Card must be held on file for **Damages and Returned** no longer than (3) **three** business days after pickup, and an assessment of **ALL** items has been made.
6. Renter shall keep items Clean and Properly Maintained while in their position.
7. Renter shall be liable for all Damage incurred while under their care, caused from such as (Standing, Improper Usage, Improper Care, Over Stacking, etc.)
8. Coolthings Inc. shall be compensated for the Full Replacement Cost for all unrepairable damages.
9. While in Renter's care Furniture cannot be **Loaned, Rented, or Used** in any other location **without the Written Consent or Acknowledgement from Coolthings Inc.**
